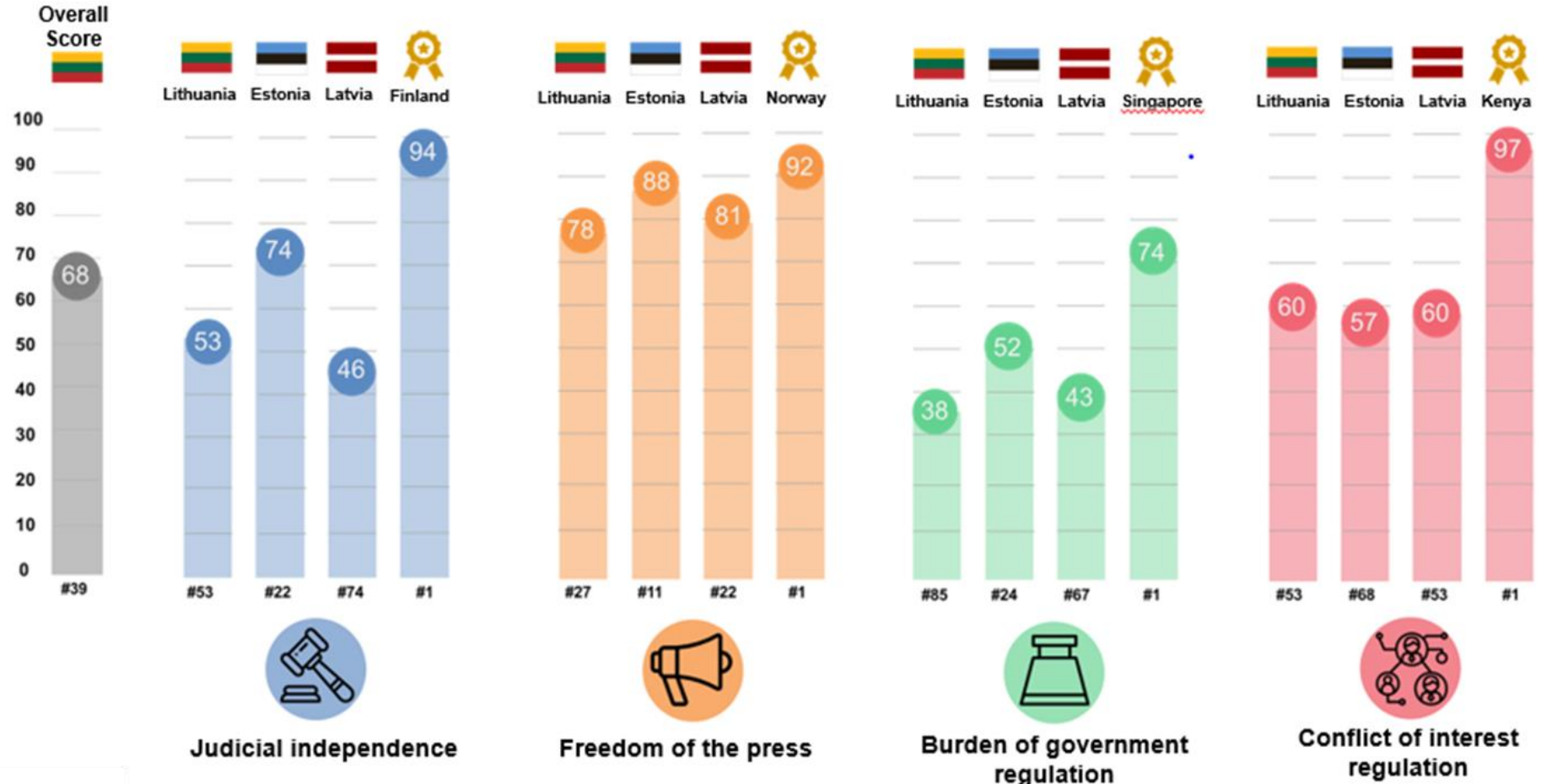

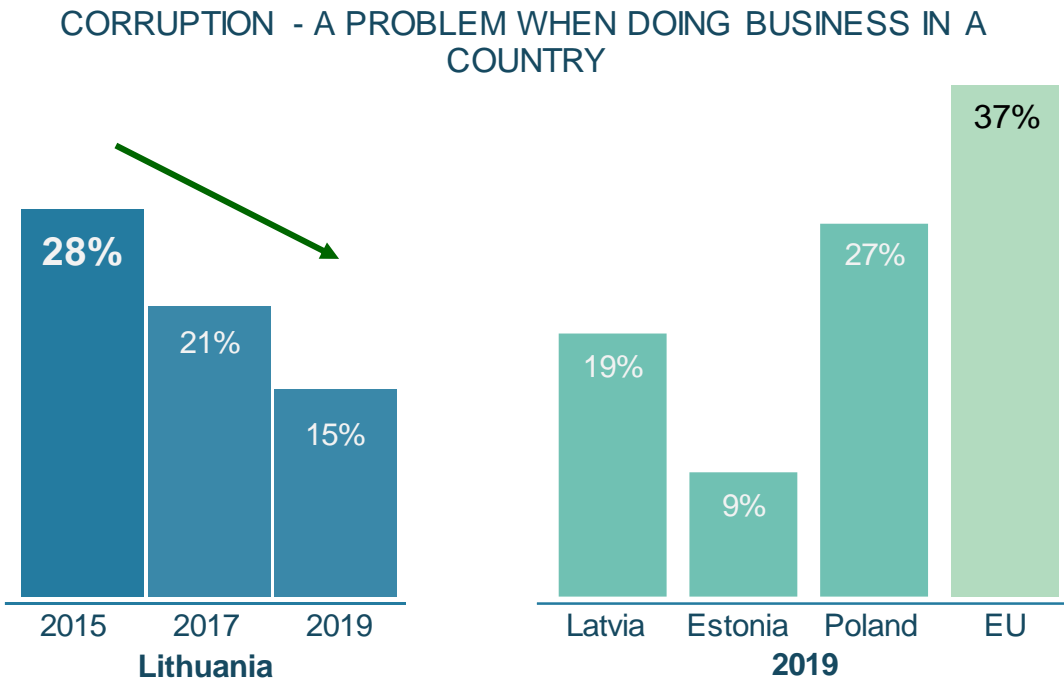
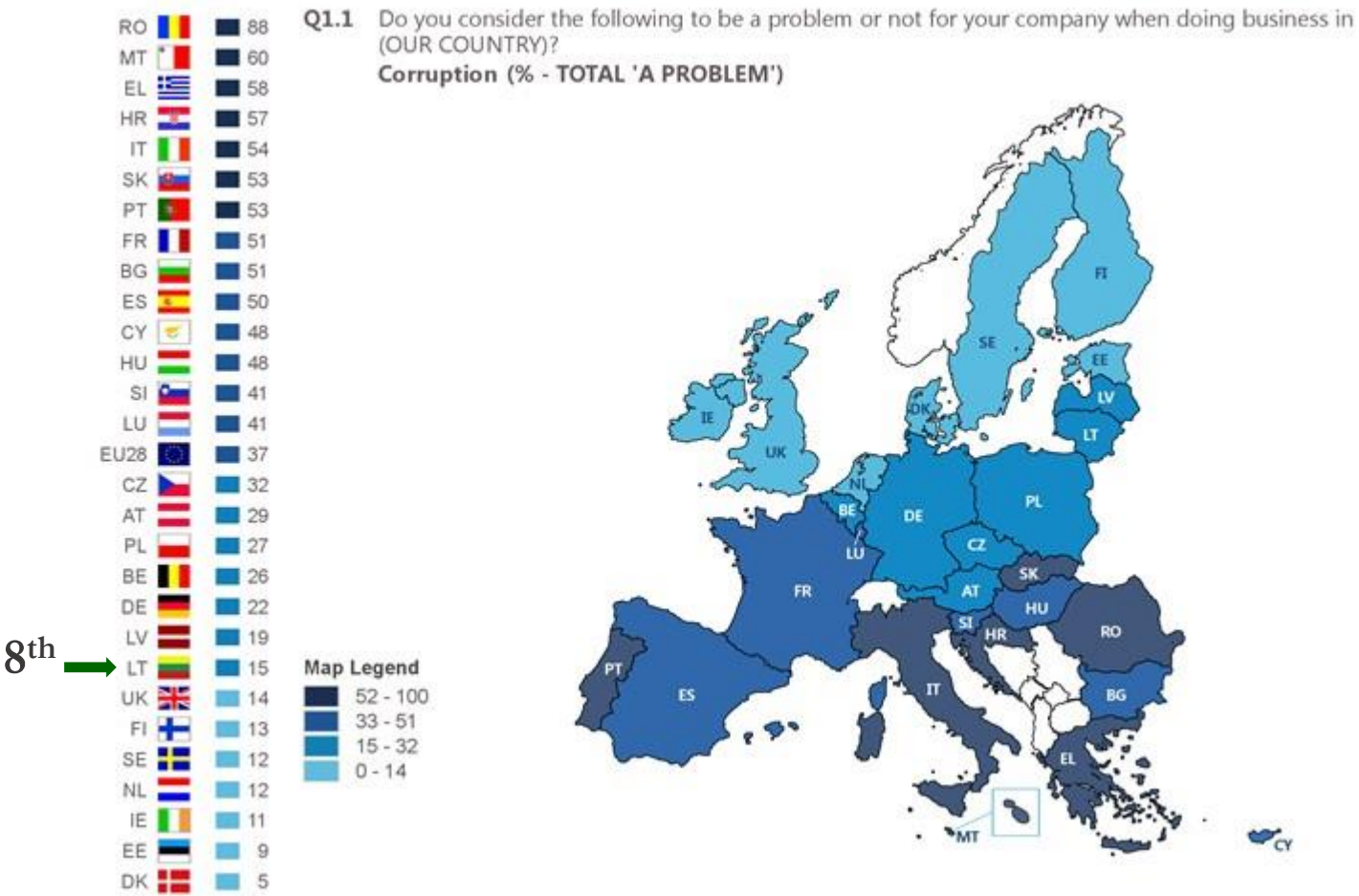

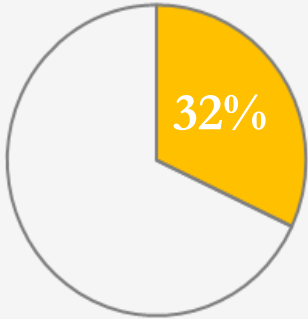

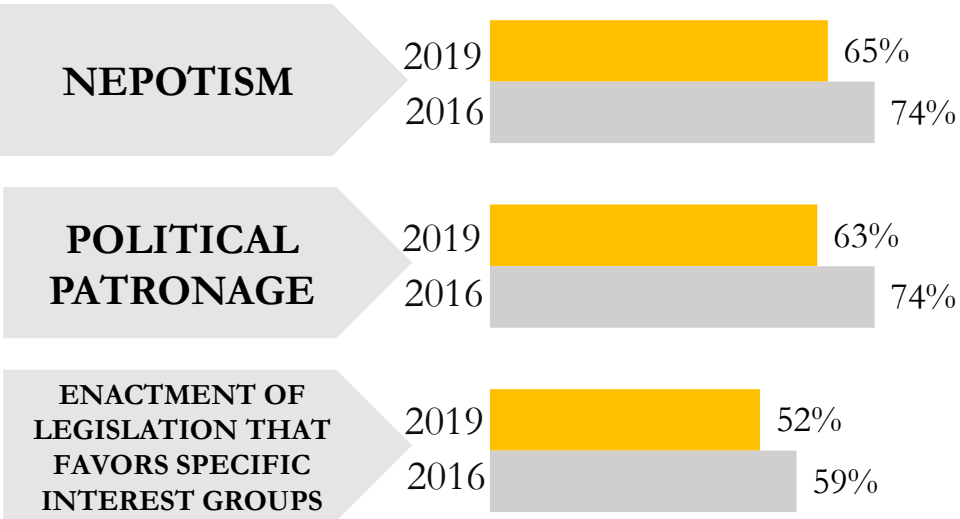

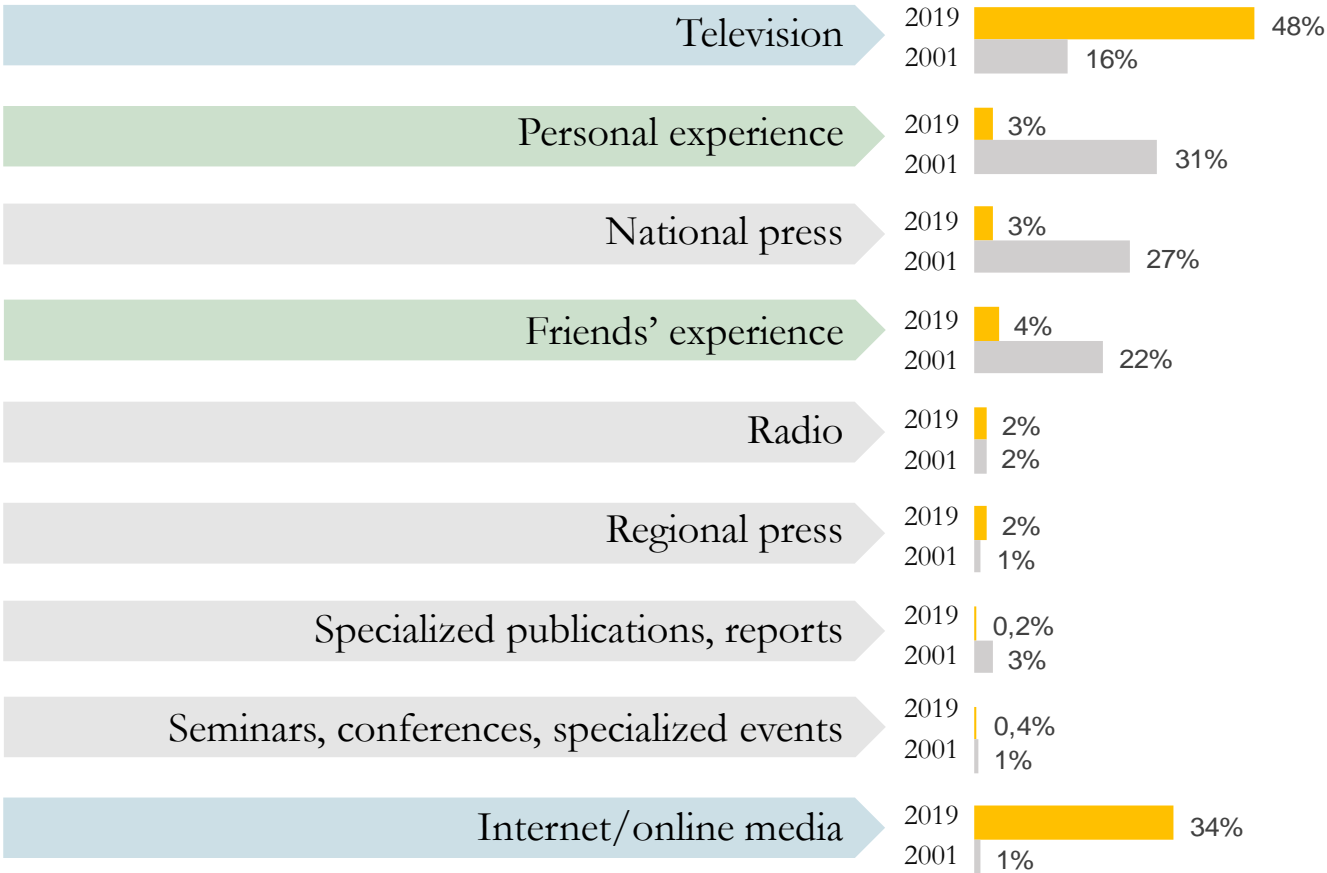

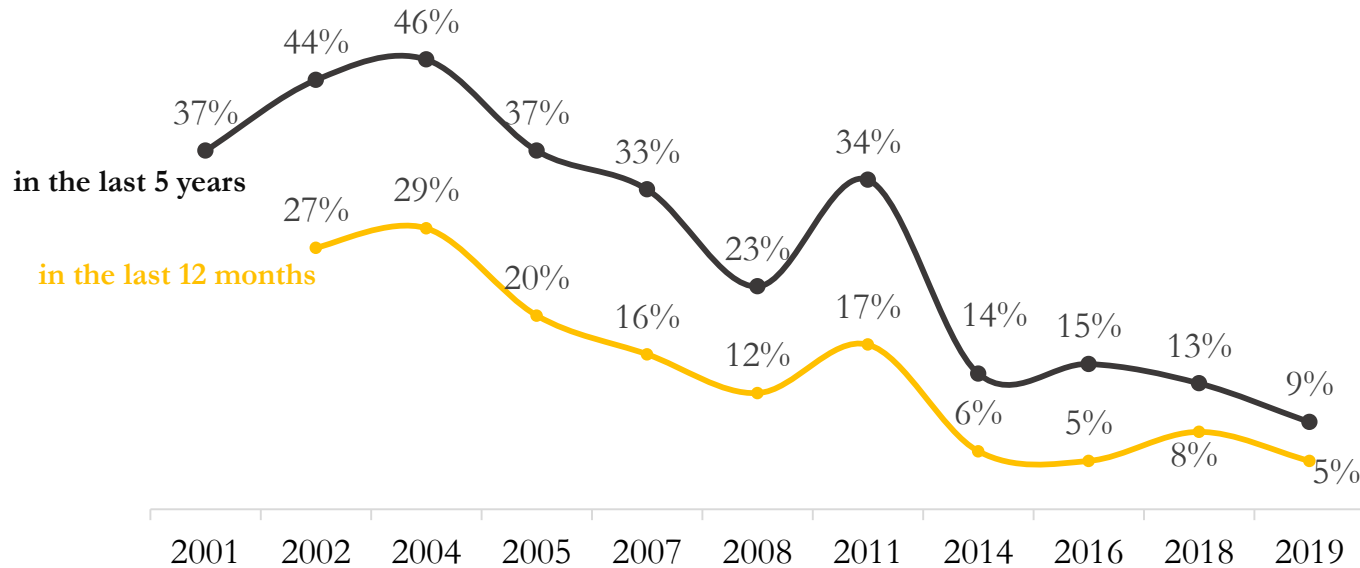

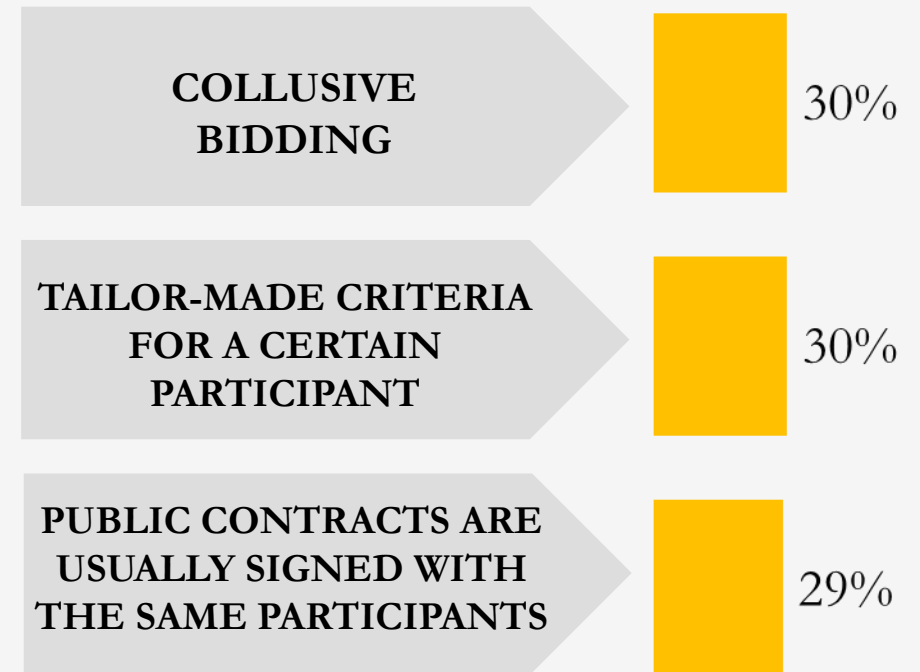


# EXPERIENCE OF CORRUPTION WHEN DOING BUSINESS

(2001 – 2019)



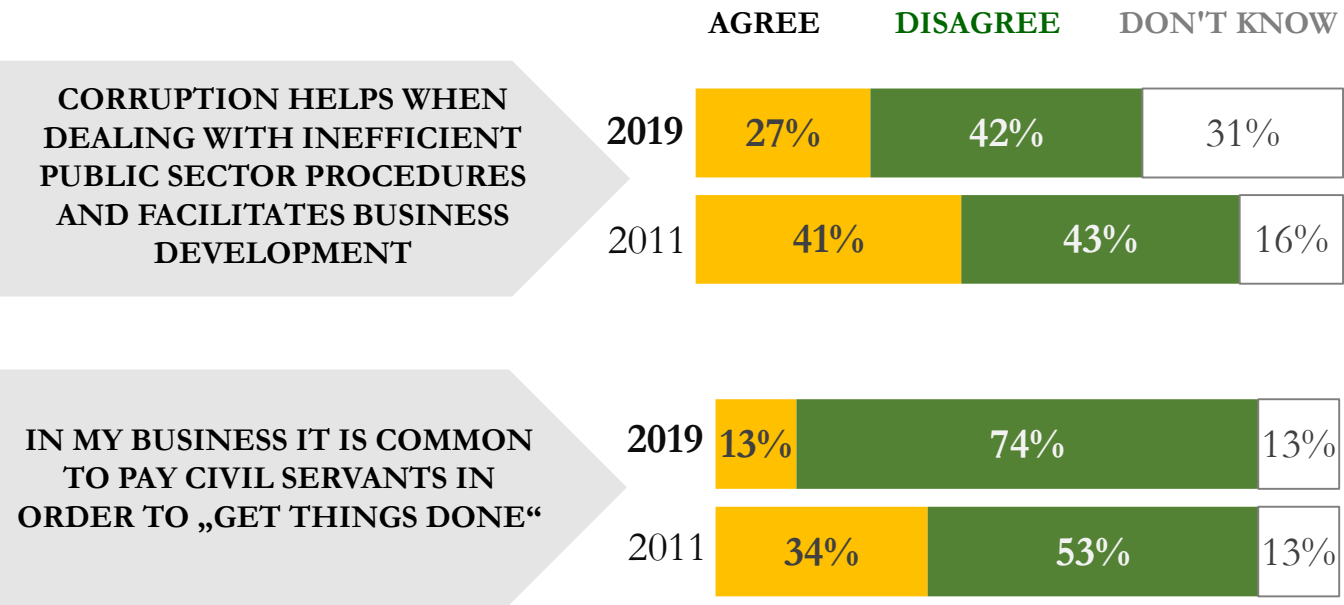

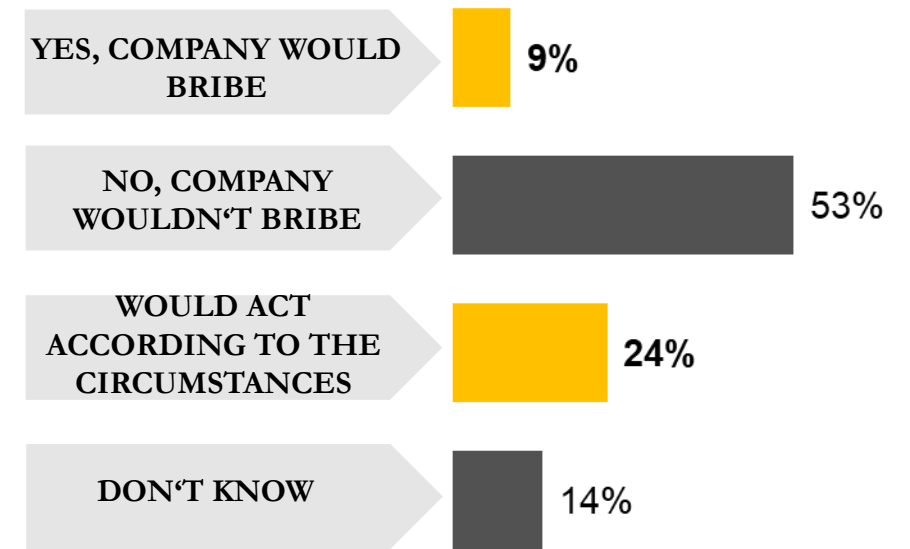

Do you agree with the following statements?



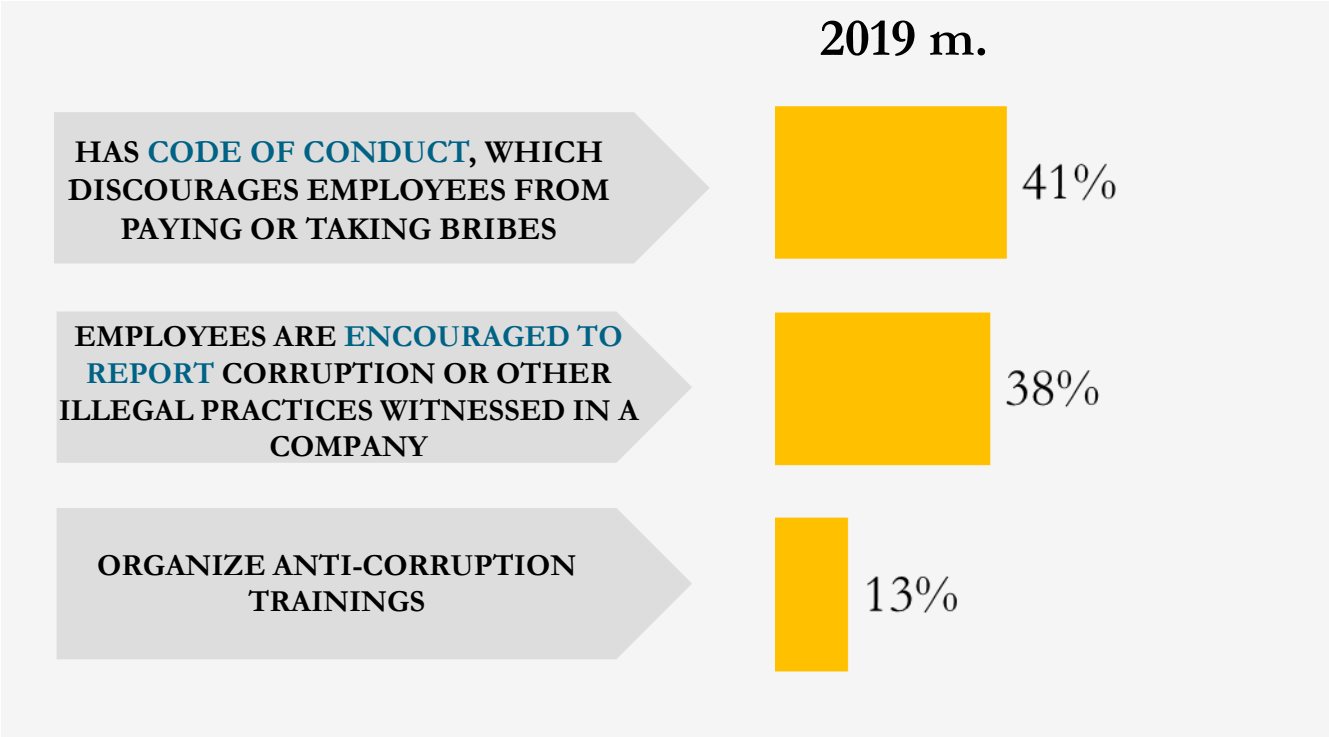
Would your company bribe in order to solve a business problem? (2019)

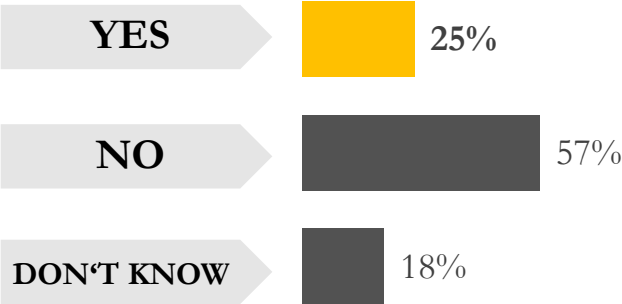

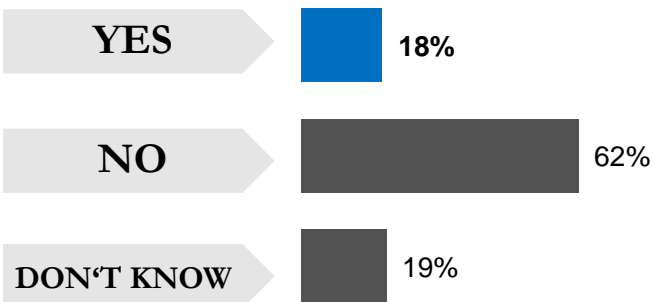
